BACKGROUND

El Rio Health is interested in exploring the availability of BRCA 1 and 2 genetic testing for patients who have been referred to obtain such testing by their provider.

This is a Request for Information (RFI) only. This RFI is issued solely for information and planning purposes, and it does not constitute a Request for Proposal or a promise to issue an RFP in the future. This RFI does not commit El Rio Health to contract for any service or supply whatsoever. Further, El Rio Health is not seeking quotes at this time and will not accept unsolicited quotes. Respondents are advised that El Rio Health will not pay for any information or administrative costs incurred in response to this RFI, and all costs associated with responding to this RFI will be solely at the expense of the interested party.



SCOPE

El Rio Health will not be drawing blood or taking patient specimens for the BRCA 1 and 2 genetic tests. Providers will be referring patients to a company that can perform the testing and provide the results to the ordering El Rio Health provider, preferably through our EHR Epic.

El Rio Health requests the following information from your company:

1. Is your company able to limit genetic testing to just BRCA 1 and 2?
2. Provide the self-pay patient cost for each of the tests listed above.
3. Describe the ordering process including electronic vs paper.
 - a) What documentation is required to be completed by the provider team?
4. Is your company able to obtain the specimen at one of your locations or using a mobile drawing station? Genetic specimens will not be obtained at any El Rio Health Center locations.
5. Is your company able to bill the patient's insurance directly?
 - a) What insurance companies do you currently contract with?
6. Describe the method utilized to report results to the ordering provider?
 - a) Are the results provided to the ordering provider prior to the patient?
 - b) Is it possible to interface results with El Rio Health Epic EHR?

RESPONSES

1. Responses should include only the information requested and not other marketing materials.
